Cash Back Offer Terms & Conditions: This section sets out the Terms and Conditions for the Bosch Cooling Cash Back offer and details how to claim your cash back. 'Purchaser' means a resident of Australia who purchases a Bosch bottom mount refrigerator from a participating Bosch reseller in Australia during the promotional period, and is the end user of that Product. 'Product' means any Bosch bottom mount refrigerator purchased during the promotion period from a participating Bosch reseller in Australia excluding models deemed as invalid in these Terms and Conditions. 'Promoter' means BSH Home Appliances Pty Ltd (ABN 22 109 198 405) of 7-9 Arco Lane, Heatherton, Victoria 3202. 'Promotional Period' means the period between 1 December 2008 and 30 January 2009 (inclusive). **1.** Instructions on how to enter and redeem your Cash Back form part of these conditions of entry. **2.** To be eligible to claim a \$100 Cash Back, you must purchase one of the following Bosch bottom mount refrigerators during the Promotional Period: KGN53X00AU and KGN53X70AU.
