1. Information on how to claim and information in relation to the offer form part of these terms and conditions. Participating in this offer is deemed acceptance of these Conditions of Entry.

2. Offer is only open to Australian residents. The directors, management and employees and their immediate families, of Unilver and the Promoter, its related companies, agencies, suppliers and Whirlpool retailers are ineligible. Offer only available to consumers and not available to business or commercial buyers.

3. The Promoter reserves the right at any time during and/or after the closing date of the offer, to verify the validity of claims and to disqualify any claimant who tampers with the claiming process or who submits a claim that is not in accordance with the Conditions on Entry. Failure of the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

4. Offer commences 1 October 2008 until close of business of participating retailers on 31 January 2009 (the Offer Period).

5. Redemption of this offer is open from 1 October 2008 until close of business on 16 February 2009. Redemption forms received after this date will be deemed invalid and claimants will not receive their nominated one year's supply of Omo front load washing powder.
