



**TERMS & CONDITIONS : BONUS 3 MONTH FINISH STARTER KIT ON SELECTED HAIER DISHWASHER PRODUCT PURCHASES ("Promotion").**

1. Instructions and information on how to claim the Bonus Gift (defined below) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. Claims are only open to Australian residents. Employees (and their immediate families) of the Promoter, participating retailers and agencies associated with this Promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister or 1st cousin. This offer is not available to trade (commercial) or wholesale customers, and includes but is not limited to purchases made by customers that do not generally sell direct to the public.
3. The Promotion is available at participating stores nationally and commences on AEST 9:00am 1.6.15 and ends on AEST 11:59pm 31.7.15 ("**Promotional Period**"). Online redemption forms must be completed by AEDT 5.00 pm 31.10.15.

**Promotional Offer:**
