

Buy an eligible Bosch Unlimited 7 vacuum cleaner and claim a Bonus Bosch power tool.

Offer Conditions

Below are the Conditions for the Bosch Bonus Power Tool Promotion (Offer) including eligibility, exclusions and details of how to claim the Bonus.

1. Participation in this Offer constitutes acceptance of these Conditions. 2. Definitions: Bonus means one Bosch AdvancedImpact 18 - Baretool (06039B510C) valued at RRP \$169.00 for each Eligible Appliance purchased, during the Offer Period. Eligible Appliance means an eligible Bosch Unlimited 7 vacuum cleaner (White BCS711WAU, ProAnimal Red BCS71PETAU, ProPower Black BCS712FCAU) purchased and paid for in-full, in one transaction, from the Bosch Online Shop or, an authorised Bosch reseller in Australia that is currently listed on the Bosch Home Appliance website (www.bosch-home.com.au) during the Offer Period, excluding Ineligible Products or Ineligible Purchases. Ineligible Products means any project or commercial purchases, trade seconds, scratch and dent stock, discount clearance outlet purchases, ex-display or used stock. Ineligible Purchases means any lay-bys or similar arrangements (unless initiated and paid for in full during the Offer Period), hire purchase or rental agreements, purchases made from the Promoter's Employee Shop and returned purchases. Claimant means a resident of Australia with a residential address in Australia, aged 18 years or over, who has purchased and paid for the Eligible Appliance(s) in full, during the Offer Period and is the end user of the Eligible Appliance(s). Online Form: the Online Form must be completed in full and must include a copy of the original invoice which clearly shows the Eligible Appliance(s) purchased and paid for in full within the Offer Period. Claims will not be accepted by email, fax or any other means. The Promoter accepts no liability for claims that are delayed or misdirected. 5. Nature of the Bonus: claimants will receive a confirmation email once the Online Form is submitted and received by the Promoter. If the claim is successful, the Bonus will be sent to the Australian residential address provided by the Claimant. Multiple Bonuses permitted subject to complying with these Conditions. 6. Verification: the Promoter reserves the right, at any time, to verify the validity of any claimant (including a claimant's identity, age and place of residence). 7. Discretion: the Promoter reserves the right, in its sole discretion, to disqualify any claimant who the Promoter has reason to believe has breached any of these Conditions, tampered with the claim process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Offer. Any misrepresentation or fraudulent information supplied by a claimant disqualifies their claim. The Promoter's decision on all matters pertaining to the Offer is final and binding and no correspondence will be entered into, except as otherwise stated in these Conditions (if at all). 8. Transferability and substitution: Bonuses, or any unused portion of a Bonus, are not transferable, assignable or exchangeable and cannot be taken as cash, cheque or electronic transfer. In the event of the Bonus, or any part of it, not being available (e.g. due to supply shortages) the Promoter reserves the right to substitute the Bonus, or any part of it, with goods of corresponding value. 9. Promoter's employees: the Offer is not open to employees of the Promoter and their immediate families (or their associated agencies) unless the Eligible Appliances are purchased from the Bosch Online Shop or a Bosch authorised reseller in Australia, in accordance with these Conditions. 10. Promoter means BSH Home Appliances Pty Ltd (ABN 22 109 198 405) of 1555 Centre Road, Clayton, Victoria 3168. 11. Privacy: the Promoter collects personal information (PI) in order to conduct the Offer and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, Prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this PI. The Promoter will also use and handle PI as set out in its Privacy Policy, which can be viewed at www.bosch-home.com.au (follow the 'Privacy' link) or by calling BSH Home Appliances Customer Service on 1300 369 744. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, for an indefinite period, unless otherwise advised, use the PI for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the Eligible Entrant. The Privacy Policy also contains information about how Eligible Entrants may opt out, access, update or correct their PI, how Eligible Entrants may complain about a breach of the Australian Privacy Principles or any other applicable laws and how those complaints will be dealt with. Unless otherwise indicated by the Promoter, the Promoter may disclose PI to entities outside of Australia (for a list of the countries, see the Promoter's Privacy Policy). 12. Other: a term (or part or parts thereof) of these Conditions will not apply where the term is unenforceable. Such a term (or part or parts thereof) is severable and does not invalidate the remaining terms. 13. These Conditions will be governed by and construed in accordance with the laws in force in Victoria, Australia.
