

Beko Finish Bonus Promotion Terms and Conditions

- 1. Instructions on how to claim and the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Claims are only open to Australian residents. Employees (and their immediate families) of the Promoter, participating retailers and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
- 3. Purchases must be made between 01/04/2019 and close of business on 31/05/2019 ('Offer Period'). Final claims must be received by 30/06/2019. Claims after this date will be deemed invalid.
- 4. To be eligible to claim, individuals (Claimant) must purchase Eligible Products (as listed in clause 22 below) from any participating retailer nationally during the Offer Period.

- 9. The Promoter recommends that prior to purchasing an Eligible Product the customer verifies with the retailer that they are authorised to participate in the promotion.
- 10. The Promoter reserves the right, at any time, to verify the validity of claims and Claimants (including a Claimant's identity, age and place of residence) and to disqualify any Claimant who submits a claim



that is not in accordance with these Terms and Conditions or who tampers with the claim process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

- 11. This is an online redemption only. All claims must be made by the actual purchaser of the Eligible Products as evidence by the purchase receipt. Claims by any other person will not be accepted.
- 12. If there is a dispute as to the identity of a Claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Claimant.
- 13. Claimant should allow up to forty-five (45) days from the date of claim information is approved by the Promoter, for the award of the promotion. The gift will be sent by post/courier. Claimant must provide a valid serial number at time of redemption. A claim cannot be accepted without a valid serial number.

When granting Australia Post/courier 'authority to leave', you understand and agree that this gives the courier permission to leave your parcel in a "safe place" or in a location of your choice (outside your door, or in your letterbox) without needing a signature. In this case, we and our couriers are released of all responsibility and liability for the order delivered if left unattended. This responsibility and liability transfers to you on delivery. Please note: The driver will not be able to ring you.
- 15. The Promoter accepts no responsibility or liability in relation to any delay in satisfying any claim for the promotion benefit.
- 16. If the serial number and the proof of purchase does not match the details submitted by the Claimant on the Online Redemption Form, the claim will be deemed invalid and will result in an ineligible claim. The eligible Claimant will not be entitled to receive the allocated promotion benefit until the Promoter has received the required documentation and verified the claim.
- 17. Incomplete, indecipherable or illegible claims will be deemed invalid.
