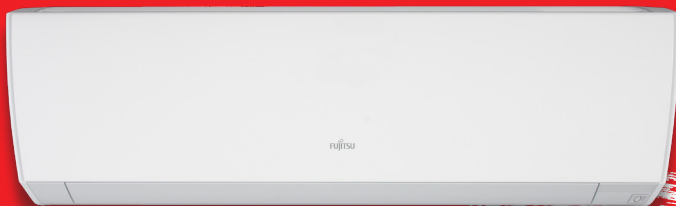

## ABBREVIATED TERMS AND CONDITIONS

1. To be eligible to claim a \$150 or \$200 eGift card, an Eligible Claimant must purchase (fully paid with zero balance owing) an eligible Fujitsu Lifestyle run-out model or Classic wall mounted reverse cycle split system (eligible models and applicable reward can be found at [www.fujitsugeneral.com.au/promotions/wintersale](http://www.fujitsugeneral.com.au/promotions/wintersale)) between **15/07/19 - 02/09/19** ("Promotional Purchase Period") from any participating Fujitsu retailer or dealer in Australia.
2. You will need your outdoor model and serial numbers and indoor model number to complete your claim.
3. The promotion is only open to Australian residents and purchases must be in the Claimant's name only. Claimants under 18 years of age must have parental/ guardian approval to enter and further, the parent/ guardian of the Claimant must read, understand and accept the full Terms and Conditions available at [www.fujitsugeneral.com.au/promotions/wintersale](http://www.fujitsugeneral.com.au/promotions/wintersale).
4. Purchases must only be for domestic and residential use and excludes non-residential applications. Purchases by, for and in the name of trusts, companies, businesses, commercial or residential developers/ developments and purchases by builders, subcontractors, installers/resellers and their immediate family, churches, not-for-profit organisations, sporting clubs and donations are not eligible. The purchaser is considered as the payer for the Eligible Products as shown on the submitted proof of payment document.
5. Employees and immediate families of the Promoter and its agencies including participating retailers and dealers associated with this promotion are ineligible to claim. "Immediate family" means any of the following: spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or 1st cousin.

7. **Claimants must successfully submit the fully completed claim form by 4:59pm AEST on 30/09/19.**
8. **In the case of Claimants who have purchased an Eligible Product for their domestic/residential use during the Promotional Purchase Period, but have not yet had it delivered or installed, and therefore cannot locate the outdoor serial number in time to make a valid claim, they must contact the Promoter prior to 4:59pm AEST on 30/09/19 so that alternative arrangements for reward issue can be made. No claims will be accepted under any circumstances after 4:59pm AEST on 30/09/19.**
9. The Claimant has until 4:59 pm AEST on 31/10/19 to lodge any additional or correct documentation should Fujitsu deem the original claim not valid. Fujitsu will not accept additional documentation submitted after 4:59pm AEST on 31/10/19.
10. Claimants must retain their original proof of purchase and proof of payment documents (where applicable) for all claims.
11. The Claimant's full name must appear on all documentation provided to verify ownership and entitlement to claim.
12. At the sole discretion of the Promoter, claim forms completed by third parties on behalf of Claimants may be rejected.
13. **The promotion commences 9am AEST on 15/07/19 and ends for purchases at 4:59pm AEST on 02/09/19. Final claims and entries close at 4:59pm AEST on 30/09/19.**
14. Offer not valid in conjunction with any other offer.
15. The Promoter reserves the right, at any time, to verify the validity of claims and Claimant's (including a Claimant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the claim process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
16. Any claim form which is incomplete, indecipherable, invalid or does not comply with the Terms and Conditions outlined will not be accepted and is ineligible for an eGift card. The Promoter will notify Claimants by email upon validation of their claim.
17. For the purposes of this promotion, only the purchase of an eligible Fujitsu Lifestyle run-out model or Classic wall mounted reverse cycle split system will be considered and the Claimant will be entitled to only one (1) relevant eGift card in respect of that purchase.
18. Multiple claims and entries permitted, subject to the following: (a) only one (1) claim permitted per Eligible Product purchased during the Promotional Purchase Period; and (b) each claim must be submitted separately and in accordance with claim requirements. Multiple product purchases may be lodged under the one claim.
19. Claimants must allow up to four weeks for validation from submission of a complete claim. The Claimant will be sent an email with an eGift card redemption code to the email address provided on the claim form when notified of claim approval. The eGift card redemption code may be used to redeem a valid eGift card for goods or services at one of the nominated retailers or suppliers in Australia.
