

# SUNBEAM MIXMASTER & BONUS SISTEMA CAKE BOX

## HOW TO CLAIM

1. To be eligible to claim, subject to the additional terms and conditions in this document, individuals must purchase an eligible Sunbeam product(s) (outlined in clause 4) at a participating store nationally between 1 July 2018 and close of business on 30 September 2018 ("Qualifying Transaction").
2. To claim, individuals must visit **[www.sunbeam.com.au/cakebox](https://www.sunbeam.com.au/cakebox)**, follow the instructions on screen where they will be required to input all requested contact details on the online form as well as uploading a legible copy of their receipt.
3. The 'Bonus Sistema Cake Box' will be provided in the form of products outlined in Clause 6. Final claims must be received online by 11.59pm AEST on 16 October 2018 or whilst stocks last. Any claim received after 11.59pm AEST on 16 October 2018 or after stock has run out will be deemed invalid. Copies of receipts which are submitted to support a claim must include: eligible product/s, date of purchase and receipt number.

## TERMS AND CONDITIONS

2. **Terms:** Information on how to claim and redeem a 'Bonus x1 Sistema Cake Box' (the "Prize") forms part of these Terms and Conditions. Participation/entry into this promotion will be deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
3. **Promotional Period:** The Promotional Period is from 1 July 2018 to the close of business of on 30 September 2018. An Eligible Product must be purchased within the Promotional Period to entitle the claimant to claim. Final claims must be completed online by 11.59pm AEST on 16 October 2018 and whilst stock lasts.
4. **Eligible Products:**

  - b. An Eligible Product must be purchased at a participating store. The Promoter does not guarantee that each store will stock the Eligible Product during the Promotional Period. We suggest you contact the retail store to ensure the products you wish to

buy are available.

**5. Eligibility and Entry conditions:**

- a. Claims are only open to Australian residents aged 18 years or over.
- b. Employees (and their immediate families) of the Promoter, participating stores and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- c. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process.
